Parking Permit Agreement

This parking permit agreement is for the non-exclusive use of one available parking space in the Gibson Parking Lot upon the terms stated as follows.

Parking permits are valid from the 1st day of the month thru the last day of that calendar month. Daytime parking permits are valid seven days a week from 5:00am to 5:00pm. 24 hour parking permits are valid seven days a week 24 hours a day. Daytime Permit price is \$32.00/mo + tax(\$1.76), 24 hour permit price is \$38.00/mo +tax(\$2.09). Renewal of monthly parking permit is due on or before the first of the month.

Parking Permit provided by Manz Companies must be properly displayed and visible at all times when parked in Gibson Parking Lot. Any vehicle without a valid parking permit properly displayed will be towed at the vehicle owners expense. Parking Permit may be terminated at the end of calendar month without further notice. Parking Permit may be terminated for violation of policy at any time. A replacement parking permit is available for lost or damaged parking permits, for \$10.00.

Parking space is to be used only for single vehicle parking, the vehicle must be as identified in this agreement, and shall be functional and have a current state issued license and active insurance. Please notify Manz Companies of any change of vehicle, license plate information, or other information.

Vehicle must be parked in a parking space, any vehicle parked in a driveway or access route or obstructing access to other parking spaces will be towed without notice at vehicle owners expense.

Removal of snow will occur within 24 hours of the end of a snowfall of 2” or more. Snow removal will start at various times depending upon the time of the end of the snowfall. When a vehicle occupies space on the parking area or driveway, that space will not be cleared (we will make our best attempts to clear around that space so access to that vehicle is not inhibited).

Manz Companies is not responsible for any damage to vehicle, theft of vehicle, or theft from vehicle. Vehicle and contents must be secured when parked in Gibson Parking Lot.

Manz Companies does not offer or provide any additional services.

Any and all items not stated in this agreement will be handled in accordance with Wisconsin laws.
